### Responsibilities and Terms of Use

- IMPORTANT** - The following three signatures must be obtained prior to submission of the completed registration form
- (1) Applicant;
  - (2) a Leader, or an official of your Spiritual Community, whose signature verifies that you volunteer on behalf of your specified Spiritual Community unless the Applicant is the Leader for the specified Spiritual Community; and
  - (3) Island Health Spiritual Health Practitioner
- Island Health Traffic & Parking Regulations (The Regulations) are available through Island Health Parking Services.
  - It is the responsibility of the applicant to review and become familiar with The Regulations.
  - Island Health utilizes license plate based parking enforcement. License plates must be registered with Parking Services to park in designated areas, subject to local site restrictions. Only one registered vehicle may be on site at a time. Applicants who park with unregistered plates will be subject to a Violation Notice. Notes left on vehicles will not be honored.
  - Parking is registered to the applicant and provides for parking in public designated parking areas only.
  - Registered parking is not valid in disability parking stalls unless a valid provincial approved disability permit is displayed.
  - Registered parking is not valid at street meters, parkades/garages, or other specialty designated areas.
  - Registered parking is for use only when visiting on behalf of one's community. When not on duty holders must park their vehicles in designated public areas and purchase public parking.
  - Applicants are responsible for keeping track of their parking registration expiry date and obtaining and submitting a new application for renewal. Applications are available from Island Health Spiritual Practitioners or Island Health Parking Services.
  - Parking on Island Health property is NOT guaranteed.
  - Parking privileges will cease when your Island Health relationship ends. The applicant is required to contact Island Health Parking Services to exit the parking program.
  - If you receive a Violation Notice, please refer to the back of the notice for instructions on how to pay, contact information for the parking management company, and instructions on how to dispute the violation. Payment and dispute matters must be addressed with the parking management company.
